2. *PRIORITY DISCUSSION/ACTION ITEMS

2.1 *Appointment of the Assistant Superintendent of Schools

Superintendent Sullivan stated that earlier that day Dr. Charles Hewes was appointed as the Deputy Commissioner for the State of Connecticut. Superintendent Sullivan congratulated Dr. Hewes.

Mr. Sullivan stated a search committee did a nationwide search for an assistant superintendent given Dr. Hewes' departure. Mr. Sullivan stated that the committee unanimously chose Ms. Jessica Kuckel. He stated that Ms. Kuckel began her career in education as a social worker for the Milford Public Schools and later for the Capital Region Education Council (CREC). Mr. Sullivan spoke further in regard to Ms. Kuckel's experience and stated that she has a Masters in Social Work from Southern Connecticut State University, a 6th year degree from the University of Bridgeport and completed the Executive Leadership program at Central Connecticut State University in 2020. Mr. Sullivan said that Ms. Kuckel began working in the South Windsor Public Schools as the Supervisor of Elementary Special Education in 2014. Mr. Sullivan stated that three years later, she was appointed Director of Special Services and last year she was promoted to the role of Executive Director of Student Services. Superintendent Sullivan said that her wide range of experiences, especially in related services and special education, should be an asset to the Colchester Public Schools He stated that he is excited to bring her before the Board as the recommended candidate for Assistant Superintendent of Colchester Public Schools
